The AI Copyright Transparency Act

AB-412 (AI Copyright Transparency Act) received overwhelming support this year. Because a broad and varied coalition of countless organizations and individuals spoke up, we were able to secure a special CA legislative hearing to highlight the importance of this issue and keep moving the ball forward for this bill.

The hearing is being held in the heart of Silicon Valley - **SHOW UP!** We need **EVERYONE** there! We want the sea of human creativity that is CA to be in the room! Also, for those who've been supporters of AB-412 **BE AT THIS HEARING**; and (if you are a supporting organization) we ask that you ask your members to be there as well.

WHAT:

There will be four panels of experts and witnesses giving testimony. This will be followed by a public comment segment. This is where you come in - **WE NEED YOU!**

Comments should be no longer than 15 seconds. They should include: your name, where you are from, what you do or what you are known for. Followed by ONE sentence either (in support of AB-412 as it is currently written), OR (how you have been impacted), OR (why you believe CA needs to do everything we can to push for transparency of these AI model datasets to protect artists & creatives everywhere).

AB-412 increases transparency for the use of copyrighted materials to train GenAI models. The bill requires GenAI developers to provide us with information about how OUR materials have been used to train THEIR models.
